



## **Nurse Aide Phase I or 75-Hour Course Nurse Aide Orientation Course # 1418 Nurse Aide Class Course # 1416**

The purpose of this course is to educate students in the basic level of knowledge and the demonstration of skills to provide safe, effective resident care. This course meets the requirement of the Department of Inspection and Appeals for nursing assistants / direct care givers working in long-term care and skilled facilities. Upon completion, a student is eligible to take the written and skills performance competency tests to become a Certified Nursing Assistant in the State of Iowa.

### **Objectives:**

- Discuss characteristics and functions of an effective nurse aide
- Demonstrate the maintenance of a safe resident environment
- Discuss and demonstrate the nurse aide's role in assisting the resident in personal care needs
- Identify nutritional needs and assistance as required
- Demonstrate the role of the nurse aide in performing routine care procedures
- Identify special needs of residents and the nurse aide's role in their care

**Class Schedule:** includes mandatory two day orientation and completion of required forms, classroom, lab, and clinical experience in a long term care facility.

**All students** register in and pay for the Nurse Aide Orientation which meets on 2 separate dates of Thursday, March 21, 2019 from 2:30-4:30 pm and Thursday, April 11, 2019 from 2:30-4:00 pm. You must attend both dates in room 614.

**Dependent Adult Abuse for Mandatory Reporters** required class Wednesday, 4-10-19 from 6:00-8:30 pm at IVCE room 608, \$39, Course Number (1399).

**Nurse Aide Mandatory Orientation will meet on Thursday, March 21, 2019 from 2:30-4:30 pm room 614 and on Thursday, April 11, 2019, from 2:30-4:00 pm room 614. On Thursday, March 21 you will complete the required background check forms and other forms. On April 11 your forms, immunizations, TB results will be returned. Students must attend both dates of March 21 and April 11 at Iowa Valley Continuing Education, 3702 S Center St., Marshalltown.** You must bring a black pen and your social security card/number on 3-21-19. You will fill out the required background check forms and review class requirements. **Classroom and lab dates, time, location:** from 12:30 pm – 6:30 pm with periodic short breaks. Class dates are Monday, Tuesday, and Friday, April 12, 15, 16, 22, 23, 26, 29, 30, May 3, 6, 7, 20, 2019 held at Iowa Valley Continuing Education, 3702 S Center St, room 616, Marshalltown. Additional dates and times will be added depending upon class size and weather delays or cancellations. You will also be attending dependent adult abuse class on April 10, 2019.

**\*April 11, 2019 documentation of all required and completed immunizations and two step TB testing results are due. If you do not provide this information you will not be enrolled in the nurse aide class.**

**Clinical Experience:** A minimum of 30 hours clinical time in a nursing facility. Your clinical is tentatively scheduled for May 8, 9, 13, 14, 15, 16, 17, 2019 from 4:00 pm – 9:00 pm at the Iowa Veterans Home, 1301 Summit St, Marshalltown.

**Costs:** Background check \$25, Dependent Adult Abuse for Mandatory Reporter \$39, Nurse Aide class \$545, Nurse Aide skills exam \$95 and Nurse Aide computerized competency exam is \$55, and book. You will also incur costs for uniform, shoes, immunizations, Influenza vaccine, two step TB test, and a watch with a second hand.

**Required Book:** Nursing Assisting A Foundation in Caregiving, by Diana Dugan, RN, 4<sup>th</sup> Edition, Hartman Publishing, new or used, ISBN 978-1-60425-061-9. Available from the MCC bookstore or other online resources. Bring the book to class with you and read chapters 1-5 before the first class.

**You must complete and pass the background check which will be done at orientation in order to progress into the class.**

**Students:** be aware that you will need to have cleared the background check and have provided all of the required health/immunization/TB testing documentation, and have completed all pre-requisite requirements by April 11, 2019. **If you have not provided the required documents you will not be enrolled in the nurse aide class.**

At registration time you will need to provide your legal name, home address, phone contact information, email address, birthdate, social security number and credit card payment.
