Mandatory Reporter of Dependent Adult Abuse Home Study, Curriculum Approval # 2128 – you will

- Define dependent adult abuse.
- Understand social issues relevant to dependent adult abuse.
- Define caretaker.
- List signs of environmental, physical, and behavioral dependent adult abuse.
- Identify who is a mandatory reporter of dependent adult abuse.
- Understand the rights of the dependent adult to either accept or decline services.
- List the categories of dependent adult abuse and discuss the purpose of the Central Abuse Registry.

Mandatory Reporter of Child and Dependent Adult Abuse Home Study, Curriculum Approval # 2129 – you will
