



# 2017-2018 ECC Federal Direct Parent PLUS Loan Authorization Form

## New ECC Parent PLUS Borrower

If this is the first year that you are requesting a Parent PLUS loan, you must complete the 2 Step process below.

**Step 1** Complete the **Federal Direct Loan PLUS Master Promissory Note (MPN)**. You will need your FSA ID to electronically sign your MPN. Please go to [www.studentloans.gov](http://www.studentloans.gov) and "Sign In" as yourself (not the student). After signing in go to "Master Promissory Note" on the far left column and click on "Complete MPN". Then select the Parent PLUS option. Be sure to list Ellsworth Community College in the "School Selection" section and follow all instructions listed on the PLUS MPN.

**Step 2** Completion of this Federal Direct PLUS Loan Authorization Form gives Ellsworth Community College the authority to process a PLUS Loan credit history request on behalf of the parent borrower. If approved for credit, the loan will be processed for the amount you request below. Once completed, please return to the ECC Financial Aid Office.

- I understand that I am applying with a Master Promissory Note (MPN). I understand that I may receive one or more loans under this MPN and that I must repay such loans.
- I understand that I may choose to cancel any or all, of this loan even after the loan funds are disbursed.
- I understand that I enter repayment once the PLUS loan is fully disbursed.
- I understand that my credit history will be checked during the loan origination process.
- I am not in default on any loan made under the Federal Family Education Loan Programs/Direct Loan Programs and do not owe a refund on a grant received under the Federal Pell Grant and FSEOG for attendance at any institution.
