## WORK-BASED LEARNING CONFERENCE SCHEDULED FOR IOWA

On April 22-23, the National Work-Based Learning Conference will be held at the FFA Enrichment Center on the DMACC campus. The two-day conference is the first one scheduled in Iowa and is sponsored by the Association for Career and Technical Education (ACTE). The conference will focus on:

- National work-based learning trends
- Continued professional development for coordinators
- Workshops on professional development initiatives that build high-quality student experiences and programs geared toward instructors, counselors and administrators
