Step 1 Complete the **Federal Direct Loan Parent PLUS Master Promissory Note (MPN)**. Please go to <https://studentaid.gov> and login as yourself (not the student) with your FSA ID. From the top select “Loans and Grants” then select MPN. Click the “I’m the Parent of an Undergrad Student” button. Be sure to list Ellsworth Community College in the “Schools to Notify” section and follow all instructions listed on the PLUS MPN.

Step 2 Completion of this Federal Direct Parent PLUS Loan Authorization Form gives Ellsworth Community College the authority to process a PLUS Loan credit history request on behalf of the parent borrower. If approved for credit, the loan will be processed for the amount you request below. Once completed, **please return to the ECC Financial Aid Office.**
