NEW ECC STUDENT BORROWERS

All new ECC Direct Loan borrowers are required to complete the 3 Step process below.

- Student loan borrowers must complete *Direct Loan Entrance Counseling*. Please go to https://studentaid.gov to complete your counseling session. From the top select "Loans and Grants", then "Loan Entrance Counseling" and click on the "Log in to Start" button by "I am an Undergraduate Student". Be sure to put Ellsworth Community College in the "Schools to Notify" section. Follow directions listed on their website. You will learn your rights and responsibilities as a student loan borrower through this process.
- Step 2 Complete the *Direct Loan Master Promissory Note* (MPN). You will need your FSA ID to electronically sign your MPN. Again, please go to https://studentaid.gov. From the top select "Loans and Grants", then go to "Master Promissory Note (MPN)", click on the "Log in to Start" button by "I'm an Undergraduate Student" and then follow the directions listed on their website. Be sure to put Ellsworth Community College in the "Schools to Notify" section.
- Step 3 Complete this Federal Direct Student Loan Authorization Form and return to our office.

- I understand that all first-time borrowers must have their first disbursement delayed by 30 days.
- I understand that all funds will be credited to my student account first, with any remaining balance refunded to me according to the colleges refund policy.
