



Graduation and Transfer Rates for Federal Cohort Students Receiving Federal Financial Aid Ellsworth and Marshalltown Community Colleges

Under the federal Student Right-to-Know legislation, colleges are mandated to furnish graduation and transfer rate details broken down by gender, race/ethnicity, recipients of a Federal Pell Grant, recipients of a Federal Direct Loan who didn't receive a Federal Pell Grant, and those receiving neither grant nor loan. This report presents such information for the IPEDS first-time, full-time, degree-seeking Fall 2020 cohort.

Care should be taken when analyzing certain cohort groups, particularly those with minimal counts—cohorts with five or fewer students are marked with an asterisk (*) to safeguard privacy and highlight potential constraints in data interpretation.
