We are requesting approval of a 260F lowa Jobs Training Agreement with Cargill, Inc. in Iowa Falls, Iowa. Across the decades, Cargill has remained true to the vision of founder W.W. Cargill: helping farmers prosper, connecting markets and bringing consumers the products they're seeking. Along the way, they've advanced how food and agriculture work, with breakthroughs that changed what was possible.

In 1865, William Wallace (W. W.) Cargill became the proprietor of a grain warehouse in Conover, Iowa, at the end of the McGregor & Western Railroad line. Global expansion

happened in the 1950's and by 2015 and to the present day, Cargill celebrates over 150 years of helping people and organizations thrive. Cargill has facilities all over the nation but specifically in Iowa Falls, it is a grain and oil seed facility mostly soybeans. Cargill employs 614 people. This is the 2nd contract with them.
