Iowa Health Careers Registered Apprenticeship Program 2.0 Award Contract Agreement The purpose of this award is for the development and/or expansion of Healthcare Registered Apprenticeship Programs in Iowa. These Registered Apprenticeship programs will provide an alternative pathway to health education, degrees, and certifications. 7.1. Approval of 260F Iowa Jobs Training Agreement with Bruin Manufacturing, \$23,966

We are requesting approval of a 260F lowa Jobs Training Agreement with Bruin Manufacturing in Marshalltown, lowa. Bruin has 52 total employees. Bruin was founded in 1949. They are a custom plastic injection molding company. It began as a machine shop, then die casting, then ultimately a plastic molder. They are now in their 3rd generation of family ownership. This is the 5th contract with them. They plan to use the funding for safety training, mold design training, robotic training, and leadership training. This project will also cover the cost of two of their current employees to take MCC classes on our campus. 260F is the lowa Jobs Training. The 260F program helps lowa businesses train and upskill current employees. The program fosters the growth and competitiveness of lowa businesses by ensuring that lowa's workforce has the skills and expertise needed to compete worldwide. Training programs are customized to meet the specific productivity needs of each business. \$4.75 million is available annually statewide and matched by participating businesses.

7.5. Approval of 2023-2024 Meal Plan Charges for Ellsworth Community College and Marshalltown Community College
