7.2. Approval of Access Systems, Inc. Lease Agreement - \$181,633 Presenter: Mike Mosher

We are requesting approval of a 60-month lease/service agreement with Access Systems, Inc. to replace the expiring agreement with EO Johnson (formerly Koch Brothers) for copier services. This agreement includes servicing 32 District-owned copiers and upgrading the leased equipment in the print shop to a Ricoh 7500 production printer/copier. This upgrade is expected to enhance overall output and reduce the need for outsourced projects. The lease agreement with Access Systems will cost \$3,027.21 per month, offering a cost savings of \$293.81 per month compared to the current EO Johnson agreement.
