Strategic Agenda Outcome 3 - Partner to address diverse community and Workforce Training Needs.

IVCCD, local healthcare organizations and area high schools are partnering on a career pathway initiative to address a critical workforce shortage in healthcare. Rural Highways to HOPE creates pathways into healthcare by establishing apprenticeships in medical assisting, certified nursing assistants and phlebotomy technicians. IVCCD was awarded \$451,878 from the Iowa Health Careers Registered Apprenticeship 2.0 grant program to do this work. The project will be explained in greater detail during the presentation.
