7.4. Approval of 260F Iowa Jobs Training Agreement with Alliant Energy - \$12,080 Presenter: Neysa Hartzler

We are requesting approval of a 260F Iowa Jobs Training Agreement with Alliant Energy in Marshalltown, Iowa. Alliant Energy has 2,200 employees in Iowa and 239 employees in the Marshalltown area alone. Alliant Energy's Iowa energy company provides electric and natural gas services to 83 of Iowa's 99 Counties. The company traces its roots to the late 1800s through small power companies across the state. The company is headquartered in Cedar Rapids and has around 2,000 Iowa-based employees. This is the fourth contract with Alliant Energy, and they plan to use the funding for CPR/First Aid training as well as some other safety training.

260F is the Iowa Jobs Training program that helps Iowa businesses train and upskill current employees. The program fosters the growth and competitiveness of Iowa businesses by ensuring that Iowa's workforce has the skills and expertise needed to compete worldwide. Training programs are customized to meet the specific productivity needs of each business. \$4.75 million is available annually statewide and matched by participating businesses. Training agreement is Attachment <u>7.4.</u>

7.5. Approval of 260F Iowa Jobs Training Agreement with Ritchie Industries - \$40,133 Presenter: Neysa Hartzler

We are requesting approval of a 260F Iowa Jobs Training Agreement with Ritchie Industries in Conrad, Iowa. Ritchie Industries has a total of 69 employees. Thomas Ritchie, an Iowa farmer, invented an automatic animal watering system in 1921 for the purpose of keeping his own livestock supplied with fresh water. His invention became popular among the farmers in the area, so he patented the concept and sold it to farmers around the state out of a machine shed on his farm. Ritchie Industries incorporated in 1929 and then C.D. Wilson Sr. purchased the business in 1943 and moved it to Conrad, Iowa, where it has remained ever since. On January 15, 2004, Clifford D. Wilson Jr. sold the company to the Ritchie ESOP. This is the 7th contract with Ritchie Industries. They plan to use the funding for a variety of trainings including welding, several national conferences, maintenance and safety training, sales and marketing training, as well as a variety of Industry 4.0 topics including software system integration and automation.

260F is the Iowa Jobs Training program that helps Iowa businesses train and upskill current employees. - North, East & South Halls at MCC: \$3,375 per semester (\$6,750 annual) per single room (no increase)
- North, East & South Halls at MCC: \$2,200 per semester (\$4,400 annual) per triple room
