Call to Order:

Board President Hofer called the regular session of the Iowa Valley Community College District Board of Directors to order at 4:00 p.m. on Wednesday, January 8, 2025 at the IVCCD Administration Building Board Room, 3702 S. Center Street, Marshalltown, IA 50158.

Additions/Deletions to the Agenda:

Board President Hofer noted Item 7.2 Approval of FY24 Audit Report would be moved up to follow the Strategic Presentation. Item 7.5, Closed Session for Collective Bargaining Strategy would be moved to the end of the meeting, noting no further action would be taken prior to adjournment.

Director Pohlson moved approval of the agenda. Motion seconded by Director Jones. Motion carried unanimously.

Introduction of and Comments from Representatives to the Board:

BCS Representative Melissa Mulder, MCC Faculty Representative Danielle Kness, and IVG Faculty Representative Lucas Shepherd shared activities about their units.

Recognitions:

Dr. Matt Schmit recognized the Fall 2024 MCC Esports students for being recognized as the top All-Academic institution in the NJCAAE. (There are over 250 school members in the league). Dr. Schmit also recognized the MCC Woman's Basketball team for having a great season at 11-3. This has them tied for third in the latest Iowa Community College Athletic Conference standings going into the winter break and on a current four-game winning streak.

Dr. Barb Klein recognized the ECC's basketball teams' success on the court this season, both being nationally ranked. The Lady Panthers were ranked 24th in the NJCAA DII standings with an

11-1 overall record. The Panther men were sitting in 9th place in the DII national rankings with an overall record of 12-2 going into break.

Strategic Presentation

Vice President of Business and Community Solutions Jacque Goodman presented along with Becky Hassett, BCS Director of Programming and Student Support, and UnityPoint-Marshalltown Hospital Administrator Shari King about the Health Careers Registered Apprenticeship Program (Rural Highways to HOPE - Health Occupations Practical Experience & Education). The objective of the program is to expand and improve training and educational programs to address regional workforce and community trends. A grant was awarded in 2023 and a strong interest was expressed by students and the community. In July 2024 the first Registered Cohort was formed and the second was formed in December 2024. There is currently a waitlist for this program. Iowa Valley has collaborations with UnityPoint Health, McFarland Clinic, Hansen Family Hospital, and other partnerships with Oakview Nursing Home in Conrad, Mayflower Community in Grinnell, and Scenic Living Communities in Iowa Falls. A new MA pilot project is beginning at McFarland Clinic.
