Call to Order:

Board President Hofer called the regular session of the Iowa Valley Community College District Board of Directors to order at 4:00 p.m. on Wednesday, January 14, 2026 at the IVCCD Administration Building Board Room, 3702 S. Center Street, Marshalltown, IA 50158.

Introduction of and Comments from Representatives to the Board:

BCS Representative Ricarda Drummer, ECC Faculty Representative Joerg Rochlitzer, MCC Faculty Representative Danielle Kness, and IVG Faculty Representative Ashtyn Beek shared about various activities.

Recognitions:

Dr. Barb Klein reported that on November 11, sixteen agriculture/pre-vet students and four chaperones boarded their first Delta flight in Minneapolis and landed a couple of flights later in Berlin, Germany to take part of the Fall 2025 Study Abroad program. The 12-day trip was filled with opportunities to learn about various aspects of agriculture, politics, and culture in Germany and Czechia. The group attended Agritechnica in Hanover, which is the world's largest trade fair for ag machinery and technology. Then, they explored key historical sites in Berlin, such as the

Brandenburg Gate, Berlin Wall, Checkpoint Charlie, and Alexanderplatz. In Dresden, the group reconnected with our college partners at the University of Cooperative Education who were wonderful hosts and tour guides through not only the beautiful downtown Dresden, but also a modern dairy facility, a flour mill, and state-of-the-art equine breeding and riding venue in Moritzburg. At the Saxon Parliament, the group met with parliament members, Sandra Gockel and Thomas Schmidt, as well as the State Minister for the Environment and Agriculture, Georg-Ludwig von Breitenbuch. The trip concluded with a visit to Prague, where students deepened their understanding of the region's history, architecture, and cultural heritage. After mastering public transportation, navigating language barriers, paying in foreign currencies, and enjoying wonderful cuisine, the group headed home just in time for Thanksgiving with their families. Thanks to Honoria Balogh, Kevin Butt, Wanda Koehrsen, and Joerg Rochlitzer for their leadership and patience in providing this incredible experience for our students.

Strategic Presentation

Katie Lanius, Breanne Bummel, Christine Eige, and Ricarda Drummer presented an overview of IVCCD's Adult Education & Literacy (AEL) program, highlighting its service locations across Marshall, Poweshiek, Tama, and Hardin counties, the range of programs offered—including HSED, ESL, STAR reading, health-care pathways, and integrated training options—and multi-year student participation data showing steady growth in enrollment and study hours along with annual HSED completions. They also outlines the wide variety of testing services available, from nurse aide assessments to HiSET and industry certifications, and emphasizes strong community partnerships with local schools, libraries, tribal education programs, workforce agencies, and community organizations. The presentation concludes with examples of student success stories that showcase the impact of AEL pathways on educational and career advancement and a closing message of appreciation for the opportunity to share program achievements.
