

Notification of CRRSA Act Funding (HEERF II) - Ellsworth Community College

ECC signed and returned to the U.S. Department of Education the Certification and Agreement form confirming the College intends to use the allocated funds received under the CRRSAA (a)(1) program to provide Emergency Financial Aid grants to students.

ECC was allocated and received \$357,972 of CRRSAA funds from the U.S. Department of Education to disburse to students whose education was impacted by the COVID-19 pandemic.

Emergency grants are awarded to students to assist with any component of the student's cost of attendance. Funds are awarded to:

- Students who are enrolled in a degree-seeking program during Spring 2021 or Summer 2021
- Are US citizens or eligible noncitizens
- Have completed a 2020-2021 FAFSA with a calculated EFC number.

Award amounts were pro-rated based on the student's enrollment status. Grants were awarded as follows:

Spring 2021

12 or more credits	\$750
9-11 credits	\$563
6-8 credits	\$375
5 or less credits	\$188

Summer 2021

12 or more credits	\$500
9-11 credits	\$375
6-8 credits	\$250
5 or less credits	\$125

April 1, 2021 - June 30, 2021, \$313,320 was distributed to eligible students
